

GARDERIE LES FRIPOUILL

Article 1 :

The Crèche is managed by Sagets.

Article 2 :

The Crèche is open during the winter season of 2008/2009 from Sunday to Friday from 9 am to 5 pm. The Crèche is closed on Saturdays.

Article 3 :

It takes children from the age of 6 months to 4 years. It can only take 30 children at any one time.

Article 4 :

The reception desk is closed between 12.30 am and 2 pm while the children have lunch.

Article 5 :

Parents must bring a bag with the child's name on it, a snack, nappies, bottles, slippers and a sufficient number of changes of clothes.



Article 6 :

Meals are provided by the nursery for children over 10 months old. For babies, parents must bring their meals.. **Only the products not requiring a conservation with the cold will be accepted** (small pots baby, prepared plates, individual pasteurized milk brick). **We will not accept the dishes prepared by the parents.**

Article 7 :

Any necessary medical treatment will be administered by the staff, if they are shown the doctor's prescription. This is also true for special dietary requirements.

Article 8 :

Children will only be handed back to those who accompanied them to the Crèche in the first place, unless the management is informed of a change, and given the names of the people who are to collect the children. Children cannot be handed over to anyone under the age of 18, unless they have written authority stating the contrary.

Article 9 :

No child suspected of being ill can be accepted at the Crèche. The same applies for children who are in quarantine having been in contact with contagious diseases, or have brothers or sisters suffering from them.

Article 10 :

Children must bring their medical records to the Crèche with them. They need to have had all the obligatory vaccinations (Polio-diphtheria tetanus). In the case where for medical reasons the vaccinations have not been carried out, the parents must supply a certificate signed by a doctor confirming this decision. Parents will also be asked to give written permission for the person in charge of the Crèche to take any necessary action in the case where their child has an accident or is ill.

Article 11 :

The Crèche is not responsible for the loss of or damage to any personal objects brought there by the children.

Article 12 :

As soon as a child arrives at the Crèche, his or her name, surname, resort address and parents' telephone number must be noted down on a form.

Article 13 :

The parents undertake to ensure that their child is insured.

Article 14 :

Any reimbursement will only be paid on presentation of a doctor's certificate.

Article 15 :

In the best interests of the infant and the group the crèche reserves the right to refuse a child who is unable to settle into the crèche environment after two half days.

Article 16 :

Parents or those in charge of the children must pick them up before the time when the Crèche is due to close. If parents are seriously late, the police will be called. If this rule is not adhered to twice, the Crèche has the right to refuse to take the child again.

Article 17 :

These Crèche rules are on show at the Crèche : parents must indicate that they are aware of their contents before enrolling their child.
